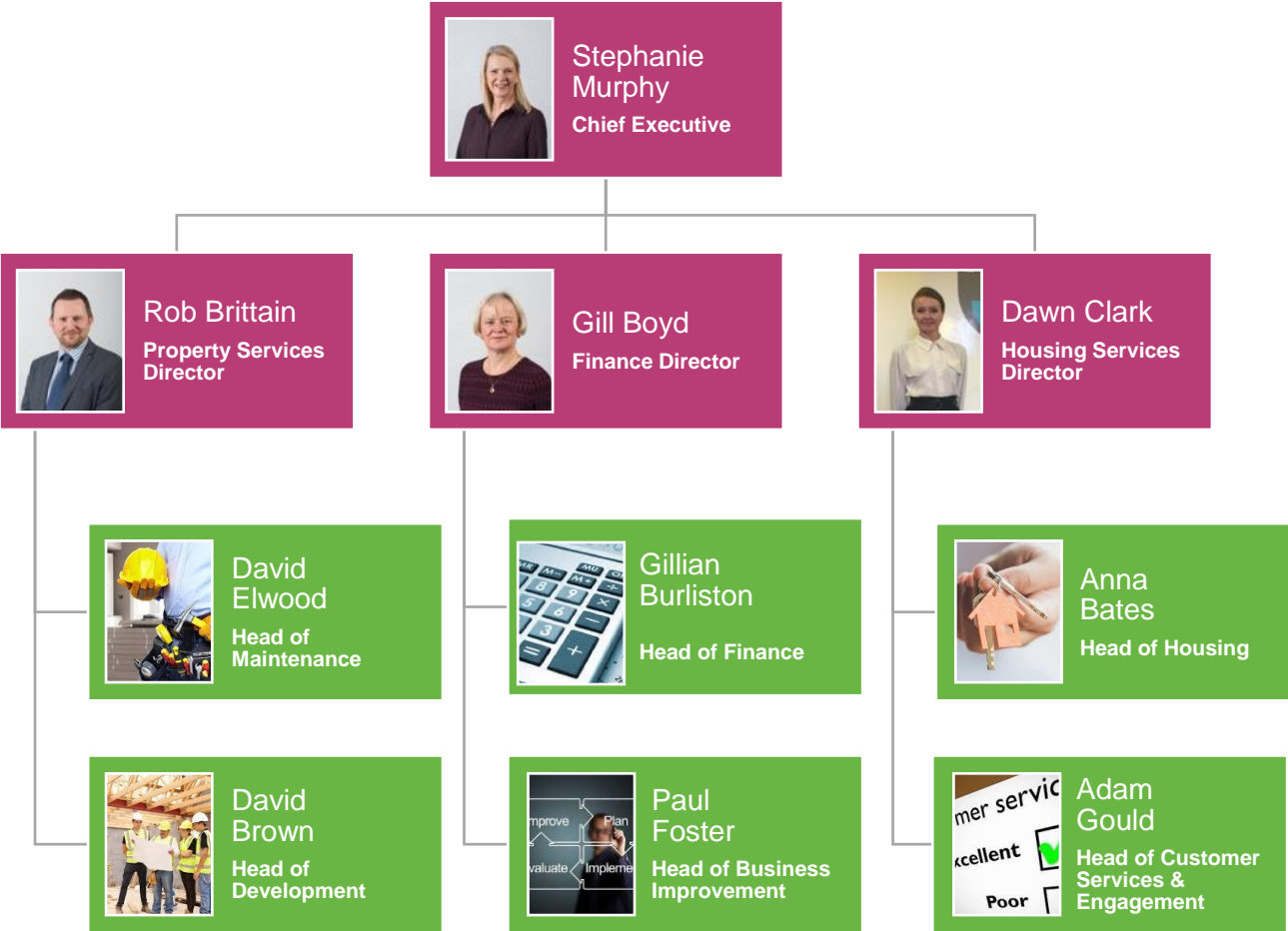

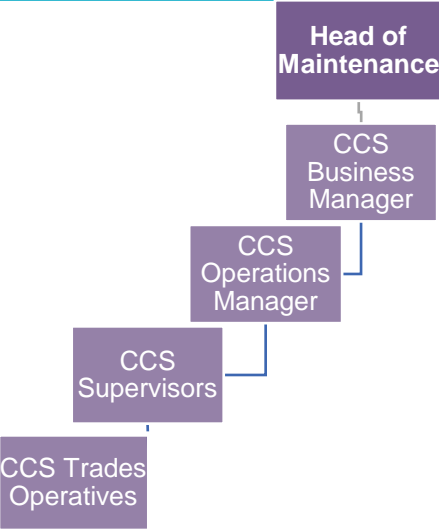

Organisational Overview



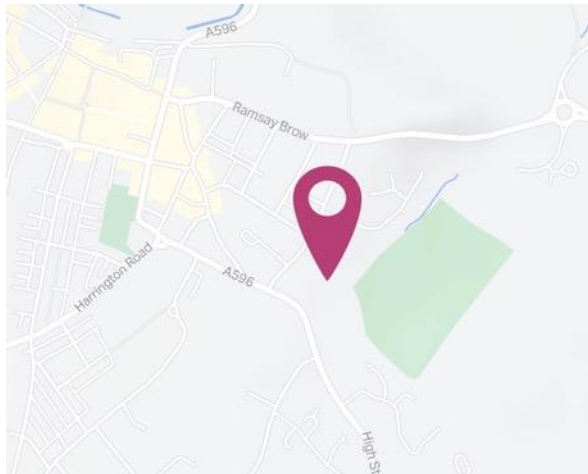
CCS Team Overview

Purpose of Job:

- To deliver works to tenanted and void properties, ensuring that your works are completed on time, to a high standard and within financial targets.
- To ensure that you and your colleagues work to the highest standards of health and safety, with professionalism and consideration towards residents and their homes.
- To contribute to the delivery of CCHA's compliance programme and provide appropriate technical expertise to ensure an effective and pro-active maintenance service.

Key Responsibilities:

- Ensure skilled works to tenanted and void properties are delivered in line with agreed quality standards and within Key Performance Indicators (KPI).
- Identify and undertake all core trade works and carry out basic non-core trade works to CCHA properties.
- Accurately record works completed and materials used.
- Undertake planned and responsive visits, completing PPM tasks, inspections and minor repairs.
- Evaluate work requirements in conjunction with others, as required, to ensure a coordinated and compliant approach to all work undertaken.
- Manage the attendance of 3rd party contractors to ensure they undertake works to the agreed standards, within budgeted and KPI targets and conduct quality audits.
- Ordering and maintenance of materials, tools and equipment, in accordance with company procedures.
- Ensure that all necessary processes, procedures, training, registers and equipment is in place and regularly audited.
- Promote a positive health and safety culture in all areas of operations.
- Promote a right first time and customer care culture in all areas of operations.
- Promote a culture of continuous improvement to support value for money.
- Respond promptly to emergency job requests, undertaking repairs as quickly and efficiently as possible.
- Report where capital purchases are needed as equipment is at the end of its life.
- Undertake surveys and reports as requested and, where applicable, maintain asset registers.

- Respond effectively to requests or complaints relating to Property Services matters.
- Provide an Out of Hours response to emergency jobs, on a rota basis.
